# RACE NOTICE

# 1. RULES

The Regatta will be governed by:

1.1 The rules as defined in The Racing Rules of Sailing (RRS).

**1.2** National prescriptions translated for foreign competitors defined in joined appendix named "prescriptions"

1.3 For Micro class rules will apply.

1.4 Part B, section II of the IRPCAS (International Regulations for Preventing Collisions at Sea) when they replace the rules of part 2 of the RRS

1.5 In case of translation of this notice of race, the French text will take precedence

# 2. ADVERTISING [DP]

Boats may be required to display the advertising chosen and supplied by the organizing authority. If this rule is broken World Sailing Regulation 20.9.2 applies (internet link to the Regulation).

#### 3. ELIGIBILITY AND ENTRY

#### 3.1 The regatta is open to :

3.1.1 All boats in accordance with their National Authority, with a category of conception D minimum CE standard or, for the boats of previous conception in this standard, officially approved at least in 5th sailing category or equivalent.

3.1.2 For Euro Micro, all boats from the Micro Class. For handicap system Osiris Habitable, ORC: A (only Micro), B, C, R1, R2, L, Sport keelboat with à corrected time and overall length.

3.2 To welcome boats and competitors within the best conditions, we are kindly asking you:

- to fill up the pdf file named "Registration form" for your boat registration and our Sunday evening event.

Then you send it by mail at : <u>euromicroparis@asm-voile.fr</u>

- to reserve your food and accomodations.

We present you with all the necessary information in the pdf file named "Accommodation registration"

3.3 French competitors (each crew member) having a FFVoile license shall present during registration:

- their valid FFVoile club license with "Competition" notation, attesting the prior presentation of a medical certificate confirming the absence of any medical objection to participate to a sailing competition,

- or their valid FFVoile club license with "Adhesion" or "Pratique" notation, accompanied by a medical certificate dated less than one year confirming the absence of any medical objection to participate to a sailing competition

- a parental authorization for the minors

- if necessary a valid authorization to display advertising on boat

- the measurement form or certificate of the boat.

3.4 Foreign competitors (each crew member) without a FFVoile license shall present during registration:

- a supporting document to justify their membership to a World Sailing Member national authority.

- the boat's measurement form or certificate,

- a proof to be insured with a valid third-party liability insurance with a minimum cover of 2 000 000 Euros.

- a parental authorization for the minors.

#### 4. ENTRY FEES

The entry fee will be as follows:

- Boat registration € 40
- Sunday evening dinner (optional) € 20 per person

#### 5. SCHEDULE

5.1 Registration and crane:

Saturday April 20<sup>th</sup> from 9 AM to 12 AM

(Possible on Friday April 19<sup>th</sup> from 2 PM to 6 PM)

- 5.2 Measurement and stamping: May take place before and during the event
- 5.3 Racing days:

Saturday April 20 <sup>th</sup>	2 PM First warning signal
Sunday April 21 <sup>st</sup>	10 AM First warning signal
	7 PM Appetizer offered by the club 8 PM Evening dinner (by reservation only, registration until April 11th)
Monday April 22 <sup>nd</sup>	10 AM First warning signal

5.4 The last day of the regatta, no warning signal will be made after 3 PM

5.5 The winners and results will be proclaimed as soon as possible after the races

#### 6. SAILING INSTRUCTIONS

The sailing instructions will be:

- available during confirmation of registration on Saturday April 20<sup>th</sup> and posted according to the FFVoile prescription.

## 7. THE COURSES

7.1 Courses will be as follows: technical and/or coastal

7.2 The location of racing area is described in Appendix "RACING AREA"

#### 8. PENALTY SYSTEM

For all classes, RRS 44.1 is changed as follows :

the Two-Turns Penalty is replaced by the One-Turn Penalty.

#### 9. SCORING

9.1 Two races minimum are required to validate and complete the regatta.

9.2 (a) If less than 4 races have been completed, a boat's series score will be the total of the race scores.

(b) If 4 races but less than 8 have been completed, a boat's series score will be the total of the race scores excluding the worst score.

(c) If 8 races or more have been completed, a boat's series score will be the total of the race scores excluding the two worst scores.

9.3 Compensated time calculation of the boats which are subjected to it, will be made according to the system time on time for the built courses, and time on distance for the costal courses.

9.4 For Euro Micro the scoring system is in real time.

# 10. BERTHING

Boats and crews will be welcomed from Friday April 19<sup>th</sup>at 2 PM.

# **11. HAUL-OUT RESTRICTIONS**

Boats shall not be hauled out between the regatta, except with and according to the terms of prior written permission of the race committee.

# 12. RADIO COMMUNICATION

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 13. PRIZES

Prizes will be given as follows: 1st, 2nd, 3rd of MICRO and OSIRIS general ranking.

## 14. DECISION TO RACE

The competitor's decision to participate in a race or to continue racing engage his own responsibility. Consequently, accepting to participate in a race or to continue racing, the competitor disclaims the organizing authority of any liability for damage (material and/or personal injury).

#### APPENDIX "NATIONAL PRESCRIPTIONS"

FFVoile Prescriptions to RRS 2017-2020 translated for foreign competitors

FFVoile Prescription to RRS 25 (Notice of race, sailing instructions and signals): For events graded 4 and 5, standard notices of race and sailing instructions including the specificities of the event shall be used. Events graded 4 may have dispensation for such requirement, after receipt of FFVoile approval, received before the notice of race has been published. For events graded 5, posting of sailing instructions will be considered as meeting the requirements of RRS 25.1 application.

(\*) FFVoile Prescription to RRS 64.3 (Decisions on protests concerning class rules): The jury may ask the parties to the protest, prior to checking procedures, a deposit covering the cost of checking arising from a protest concerning class rules.

(\*) FFVoile Prescription to RRS 67 (Damages): Any question about or request of damages arising from an incident involving a boat bound by the Racing Rules of Sailing or International Regulation to Prevent Collision at Sea depends on the appropriate courts and cannot be dealt by the jury.

(\*) FFVoile Prescription to RRS 70. 5 (Appeals and requests to a national authority): The denial of the right of appeal is subject to the written authorization of the Fédération Française de Voile, received before publishing the notice of race. This authorization shall be posted on the official notice board during the event.

(\*) FFVoile Prescription to RRS 78.1 (Compliance with class rules; certificates): The boat's owner or other person in charge shall, under his sole responsibility, make sure moreover that his boat complies with the equipment and security rules required by the laws, by-laws and regulations of the Administration.

(\*) FFVoile Prescription to RRS 86.3 (Changes to the racing rules): An organizing authority wishing to change a rule listed in RRS 86.1(a) in order to develop or test new rules shall first submit the changes to the FFVoile, in order to obtain its written approval and shall report the results to FFVoile after the event. Such authorization shall be mentioned in the notice of race and in the sailing instructions and shall be posted on the official notice board during the event.

(\*) FFVoile Prescription to RRS 88 (National prescriptions): Prescriptions of the FFVoile shall neither be changed nor deleted in the notice of race and sailing instructions, except for events for which an international jury has been appointed. In such case, the prescriptions marked with an asterisk (\*) shall neither be changed nor deleted in the notice of race and sailing instructions. (The official translation of the prescriptions, downloadable on the FFVoile website www.ffvoile.fr, shall be the only translation used to comply with RRS 90.2(b)).

(\*) FFVoile Prescription to RRS 91(b) (Protest committee): The appointment of an international jury meeting the requirements of Appendix N is subject to prior written approval of the Fédération Française de Voile. Such authorization shall be posted on the official notice board during the event.
